### **Is Medicare Contracting in Your Future? The New Medicare Supplemental Adult Day Services Benefit and YOU!**

**What We'll Cover:** For the first time, Medicare Advantage (MA) Plans are allowed to offer Adult Day Care as a Supplemental Benefit for targeted members! This is a hugely important change in federal policy because it is a step forward in recognizing the need to address non-medical determinants of health as a means to more effectively improve health and avoid unnecessary system costs. MA plans are now permitted to offer selected benefits to some members and not to others. This is in recognition that one size does not fit all members in the MA plans. Find out which national health plan is making this benefit available in California in 2019 and what to do now to begin planning for the 2020 benefit year.

Explore with us what this means for Adult Day Health Care and Adult Day Program contracting opportunities, and what CAADS is doing now to advance this new policy and prepare for 2020.
